

Report on the Webinar Observing Constitution Day of India

Objective of the Programme

Introductory Address:

♦ Key Deliberation:

Dr. Nivedita Saha, Associate Professor at the University of Kalyani, delivered an insightful and comprehensive lecture on the theme "Historical Background and Philosophy of the Indian Constitution."



The speaker began her lecture by tracing the historical background of the making of the Indian Constitution, providing a detailed account of the political and historical context leading to its formulation. She highlighted the role of the Indian National Congress and the Muslim League in shaping the constitutional framework, emphasizing how both political entities influenced the constitutional discussions and the eventual agreement on the need for a formal document.

Dr. Saha also delved into the significant influences that shaped the Constitution, particularly the Cripps Mission, the Cabinet Mission, and the Government of India Act of 1935. These historical events, she explained, played a crucial role in steering the process of constitutional development, as they laid the groundwork for discussions on self-governance and autonomy for India.

Moving forward, the speaker thoroughly discussed the composition and functions of the Constituent Assembly, focusing on its various sub-committees, with particular attention to the Drafting Committee. She acknowledged the instrumental role of Dr. B.R. Ambedkar and other

key members of the Drafting Committee in meticulously crafting the Constitution. Dr. Saha outlined how the committee's members worked collaboratively to ensure the document was reflective of the diverse needs and aspirations of the Indian populace.

In the latter part of her lecture, Dr. Saha shifted her focus to the Preamble of the Indian Constitution, providing an in-depth discussion on its basic themes. She emphasized how the Preamble encapsulates the fundamental principles of justice, equality, liberty, and fraternity, which are central to India's democratic identity.

Furthermore, the speaker examined the constitutional ideas in connection with various government programmes and initiatives over time. She explained how these ideas evolved in relation to policy decisions and governance strategies, particularly in the context of India's post-independence development. Dr. Saha also explored the introduction of liberalization in the Indian economy, linking it with the concept of a mixed economy and discussing the significance of these economic reforms in the broader constitutional framework.


